### Main responsibilities and duties:

- Receive and review all documentation related to requests for ethical evaluation of clinical trials, clinical research or pre-clinical research projects.
- Register (physically and electronically) the specific documentation resulting from the activity of the unit and keep updated the corresponding records.
- Ensure the appropriate implementation of the established administrative procedures, both for the management of data entry and for its distribution and recording.
- Return the assessments resulting from the evaluation of the Ethics Committees Drug Research Ethics Committee (CEIm) and Animal Experimentation Ethics Committee (CEEA) to the agents involved in the research projects.
- Provide advice to investigators, sponsors and Contract research organizations (CROs) on administrative procedures (requirements, procedures, documentation) to be made in the presentation of evaluation applications to the CEIm and CEEA.
- Handle all outgoing or incoming correspondence.
- Telephone assistance to sponsors, CROs and investigators.
- Ensure that the activities are carried out in accordance with the requirements established in the procedures of the quality system of the unit, promoting and implementing the continuous improvement in its field of action.
